#### 5 **HIGHWAYS**

5.1 Speed cameras, Lamport High Street

Mark Stocker reported that he was in touch with Kier with a view to identifying the post for the installation of the second camera. The Chairman thanked Cllr Sinnott for helping charge the batteries on the camera currently installed. It had been noted that speeding had been reduced when the camera was first installed but was now going up again. 5.2 LRSA

Sarah Lee reported that with the help of MP Stuart Andrew, Garmin and Apple have also demonstrated their willingness to change instructions in the same way as Google Maps so that traffic was not sent through Lamport. Highways have also indicated that there will be a change to 50 mph for part of Lamport High Street.
